2. Introduction

This document is the Federal Aviation Administration (FAA) Approved Model List (AML) for Supplemental Type Certificate (STC) Number SA00765DE, for installing the Automatic Dependent Surveillance - Broadcast (ADS-B) Out System using the BendixKing KT 74 Transponder and a qualified Global Position System (GPS) with Wide Area Augmentation System (WAAS) into eligible aircraft. Qualified ADS-B Out equipment is listed in Section 4, and approved models are listed in Section 5.

Revisions to this AML must be coordinated between the STC holder and the responsible Aircraft Certification Office (ACO), and require FAA approval.

This AML is only applicable to the 14 CFR, Part 23, Class I, II, and III civilian aircraft, as defined in Advisory Circular (AC) 23.1309-1E, which are listed in Section 5. Installations in 14 CFR Part 23 Class IV, Part 25, Part 27 and Part 29 aircraft are not authorized under this AML.

This AML assumes the following equipment is already installed on each airplane eligible for this proposed modification. The following equipment must be properly linked to meet the intended function for the system, as certified under this AML approval.

1. Transponder system, including
 - i. Standalone transponder, and,
 - ii. Technical Standard Order (TSO) Approved transponder antenna that meets TSO-C112.
2. Digital altitude data source that outputs either Gillham code or RS-232 protocol.
3. When applicable, weight-on-wheels (WOW) switch that determines airborne status by compression or extension of the landing gear strut (squat switch) and is based not solely on the landing gear position.

NOTE(S)

1. Only KT 74 Transponder software version 3.12 or later is approved for use with previously installed Garmin GNS 400W/500W Series GPS/WAAS Receiver and Garmin GTN 6xx/7xx Series GPS/WAAS Receiver.
2. Only KT 74 Transponder software version 3.13 or later is approved for use with previously installed Air Data Computer when this device is used as the source of digital altitude data provided to the transponder.
3. This STC does not include the introduction or implementation of the “ADS-B In” functionality of the KGX 150 Receiver. This STC covers installation and integration with the KGX 150 Receiver for use of the equipment as a GPS/WAAS position source for the KT 74 transponder. Integration of the equipment as part of an “ADS-B In” system and installation of the UAT antenna must be addressed per an approved means other than this STC (separate TC, STC or 337 field approval) as a prerequisite to integration with the KT 74 transponder.
4. For the Cessna 525 and 525A aircraft, the installation of GPS antenna is outside the scope of this STC. Any antenna installation on these models is to be accomplished through another approved means when integrated with the KT 74 transponder.
5. For the Cessna 525 and 525A aircraft, the installation of the replacement KT 74 transponder systems does NOT affect the airworthiness of the Reduced Vertical Separation Minimums (RVSM) system. The installer should review the RVSM equipment list and determine if the transponder is listed by model number.
